# FROM THE DIRECTOR



**E. LINWOOD THOMAS IV** Director

"In just one year, Hanover's unemployment rate has almost returned to pre-COVID levels, and we still remain well below both the State and national averages. New capital investment exceeded \$63 million, which again was a record, along with new business announcements totaling more than \$140 million."

#### Dear Community Stakeholders,

By all accounts, fiscal year 2021 was one of the most challenging on record for many sectors of our local economy, especially those small businesses in the retail and hospitality industries. For the first time in over 15 years, Hanover County experienced a net loss of over 3,000 jobs which can be directly associated with the pandemic. Though the County encountered some significant economic hardships, there were also some bright spots. Our unemployment rate spiked at 8.9% in May of 2020 at the height of the virus, but has since receded to 3.1% in June of 2021. In just one year, we have almost returned to pre-COVID levels and still remain well below both the State and national averages. New capital investment exceeded \$63 million, which again was a record, along with new business announcements totaling more than \$140 million. These investments, along with the blue collar mentality of our local business community, helped cushion the unexpected economic effects of the epidemic.

Building off our success from FY-20, the County had 150 new business announcements and expansion projects which was a 75% increase from the previous year. Though some sectors struggled, we actually saw significant growth in our logistics, manufacturing and supply chain operations which helped insulate Hanover County. The growth in our industrial tax base has been exorbitant as the County is in the process of adding over six million square feet of new space which equates to an increase of over 40% to our current offerings.

Some of our major new announcements and expansions this past year included:

Hanover, ACE Hardware/Mechanicsville,
Hanover Specialties, Mygrant Glass, ARC
Natural Surfaces, Virginia Urology Associates,
Virginia Eye Institute, Anixter, MegaWash and
the NEFCO Corporation.

Over the last year, there has never been a time when our existing industries needed our support more. The Department of Economic Development was able to touch and assist more small businesses through the pandemic than ever before. Through our small business resiliency grant program, we provided support to 58 local businesses totaling almost \$300,000. We also rolled out our first shop local campaign in almost 10 years which encouraged citizens to spend their hard-earned tax dollars through a marketing and media blitz. In all, we assisted over 670 businesses this last year alone which is almost as many businesses that were touched in the previous five years combined.

As we move into 2022, Hanover County will embark on a five-year update to our strategic economic development plan which was put on hold last year due to the pandemic. These efforts, working in partnership with the Board of Supervisors and Economic Development Authority, will help position us for sustained economic success over the coming years. Our team will also continue to leverage our local partners including the Hanover County Chamber of Commerce, Dominion Energy Innovation Center, Virginia Economic Development Partnership, Greater Richmond Partnership and Chamber RVA to support our existing businesses while working to attract new investments to the County. Though this has been a trying year by all accounts, Hanover County is well-positioned to take advantage of our strategic location, low taxes, and expedited permitting processes; not to mention, our excellent school system, low crime rates and quality of life.

In closing, I would like to personally thank our local Hanover businesses, Board of Supervisors, Economic Development Authority and community leaders for your continued support of our economic development efforts.

# **PRODUCT** DEVELOPMENT

Building on the successful implementation of the Virginia Business Sites Readiness Program (VBSRP) by the Virginia Economic Development Partnership in 2016, Hanover County Economic Development continues to work with landowners on promotion and development of key properties in the Suburban Services Area\* for commercial and industrial uses.

\*The Suburban Services Area (SSA), as defined in the comprehensive plan, makes up approximately 30% of Hanover County, and is where the Board of Supervisors has committed to concentrating investments in infrastructure and growth.

#### Northlake II

Comprised of five buildings varying between 91,000 and 192,000 square feet, each building will offer numerous dock doors, 32' ceilings, and ample parking. This property is zoned M-2.

As a result of years of collaboration with land owners, developers and brokers, the end of the fiscal year witnessed approximately 6.58 million square feet of flex, speculative, industrial and warehouse/distribution space under construction, approved, or proposed in Hanover County. Of this, approximately 1.44 million square feet has been filled, leaving about 5.14 million square feet available for lease. This vacant inventory is already garnering significant attention from companies looking to establish a presence in Hanover County, as well as existing companies greatly in need of additional space for expansion. There has also been a strong uptick in inquiries related to these projects from international companies looking to shore up, or establish, operations in the U.S. Over the next few years, these projects will house thousands of jobs in our community and contribute millions of dollars in tax revenue to support the County's schools, Fire/ EMS, Sheriff's Office, social and community services and other critical county functions.

The impact of COVID-19 on the community, combined with strong growth in the Richmond Region, affected vacancy rates this past year. Both industrial and flex space vacancy rates increased, up to 2.9% and 5.9% respectively. This is largely attributable to additional product delivered to the Hanover market over the past twelve months. This product provides much needed inventory to absorb the strong interest the region is witnessing from industrial/logistics customers. Retail vacancy increased to 4.7% this year, which can be attributed to two factors: (1) changes in consumer habit due to the pandemic and less need for certain commercial uses, and (2) several new commercial projects completed during the year which added inventory to the market. Bucking national trends of increased office vacancy, Hanover County's rate decreased to 5.4% this year. This is largely attributed to limited office product hitting the market, and economic growth in the community driving demand to absorb existing space.

# Holland Technology Park Ashland

Formerly known as the Holland Axselle site in the Town of Ashland, this property has been rebranded upon the completion of a master plan by Timmons Group. At 286 acres, and constituting nearly 7% of the total area of the Town, Ashland continues to work closely with the landowner and Hanover County on a vision to maximize development on the site. The master plan, which could take a decade or more to fully implement, shows a number of buildings on the site with the ability to accommodate a number of high-value uses such as advanced manufacturing, data center, office, life sciences, and research and development.

This building will consist of 202,000 square feet of space with 32' clear ceilings, 46 9'x10' dock doors, 12'x14' drive-ins, 158 car

# BUSINESS INVESTMENT

Despite economic challenges as a result of the pandemic, Hanover witnessed near record numbers of new and expanding businesses in fiscal year 2021.



**NEW BUSINESSES, EXPANSIONS & ANNOUNCEMENTS** 

Authority (ABC) and Virginia Department of General Services were joined by Governor Ralph Northam, Secretary of Public Safety and Homeland Security Brian Moran, County officials and other distinguished guests for a ribbon cutting ceremony on June 21, 2021 to celebrate the completion of ABC's new administrative headquarters and distribution center in Hanover County. This relocation provides Virginia ABC continued growth as a modern retailer offering enhanced service and selection for customers and increased revenues to support various programs

across the commonwealth. Throughout the summer, ABC transitioned approximately 500 staff, as well as supplies and equipment to the new Hanover County facilities in Mechanicsville. Construction on the 40-acre site near the intersection of Pole Green Road and I-295 began in February 2020. The new office is 95,000 square feet with three floors, more than 40 meeting rooms and more than 500 workstations/offices. At 315,000 square feet and expandable to 399,000 square feet, the new distribution center is approximately 37% larger than the previous ABC warehouse





# CodeBlue technology

CodeBlue Technology, a provider of comprehensive computing technology solutions to small and mid-sized businesses, relocated its Richmond-area headquarters to the Rutland Center Office Building located in Mechanicsville, Virginia in February 2021. CodeBlue Technology's extensive offerings span a wide range of services including expert consultations during the procurement of new technology, managed services including security patching, data backups and network monitoring, voice over technologies, networking, security cameras, and more. Additionally, the company provides comprehensive public and private cloud hosting.

CodeBlue owner-occupies 6,000 square feet of the new Rutland Center Office Building's third floor located at 9204 Center Oak Court. The remaining two floors, each with over 5,500 square feet, are currently available for lease. This ideal location is within minutes of I-295 and I-95 in a picturesque mixed-use development with many walkable amenities.



Following two public hearings and a special meeting, the Virginia State Water Control Board approved a Water Protection Permit in March 2021 followed by a wetlands permit granted in June 2021 by the U.S. Army Corps of Engineers for a planned \$175 million Wegmans distribution and office campus situated on a 219-acre site located off Sliding Hill Road near its intersection with Ashcake Road.



**ECC Test Lab** established operations in January 2021 in space leased from Analytics Corporation, located near Lakeridge Parkway south of Ashland, Virginia. ECC Test Lab is an ISO 17025 accredited cannabis testing lab founded in 2018 at the Virginia Tech Corporate Research Center in Blacksburg, Virginia. Its mission is to help ensure

consumer safety in the cannabis industry by providing validated testing results on the quality of hemp and cannabis products. This relocation to Hanover County allows for better access to customers, and positions ECC for strong growth and leadership in the anticipated development of Virginia's pharmaceutical and recreational cannabis industry. ECC is a small, woman-owned business that is SWaM certified by the Virginia Department of Small Business and Supplier Diversity.


Anthem announces solar power purchase agreement in Hanover County to move company closer towards 100 percent renewable energy goal.

Anthem, Inc., a leading health benefits company, made the commitment in 2019 to invest in and source 100 percent renewable energy by 2025. As a key step in that strategy, Anthem announced in September 2020 that it signed a 15-year power purchase agreement with SunEnergy1, a top U.S. solar developer, owner and operator of utility-scale solar projects. The agreement is for the output from a new 182-acre solar field located in Hanover County, Virginia.

The Hanover County solar field generates more than 45,000 megawatt hours of electricity per year.

Combined with an additional solar field in North Carolina that came online in early 2021, Anthem will have supported the development of more than 1,000 acres of solar panels that will generate more than 225,000-megawatt hours of electricity per year.

The Virginia and North Carolina solar field locations were selected based on Anthem's material load (major office and data center footprint) in the grid zone that includes both states. Anthem expects the solar field developments to generate enough renewable electricity to power all Anthem offices and data centers across the country.

# **COMMERCE CENTER DEVELOPMENT**

Despite challenges to the commercial/office sector posed since the onset of COVID-19, new commercial development continues to rise throughout Hanover County in response to demand fueled by increased residential growth.



### Wigwam Crossing

10392 Washington Highway (Route 1)

With construction nearing completion in the fourth quarter of 2021, **Wigwam Crossing** consists of a 15,000 square foot commercial building fronting Route 1. The second phase is a 1.5 acre pad that can accommodate a 7,000 square foot build-to-suit building. Plans include restoration of the original Wigwam building with an adjoining 4,000 square foot event space.



#### Kings Charter Commerce Center

Charter Gate Drive at Atlee Station Road

Delivered in early 2021, Kings Charter
Commerce Center brings commercial space
into the highly sought-after, and fast growing,
Kings Charter and Sliding Hill corridor of
Hanover County. This flex space development
consists of 25,000 square feet divisible into
units starting at 1,625 square feet, and has easy
access to I-95.



#### Montpelier Villa

16660 Mountain Road (Route 33)

Montpelier Villa is proposed to consist of 48,400± square feet of commercial and office space. There is a 4,400 square foot office on the site, which will be joined by approximately 29,000 square feet of retail space, 7,800 square feet of restaurant space and about 7,000 square feet of additional office space included in the conceptual plans.

**Green Air Inc.**, an air conditioning installation, maintenance, and repair company, purchased the Redman Building located at 11250 Hopson Road in Ashland, VA for \$2.7 million.

**The NEFCO Corporation**, a fabricator and distributor of fasteners, support systems and other construction supplies, leased 83,217 square feet at Northlake Building C on North Lakeridge Parkway in Ashland, VA.

**Anixter**, global distributors of communication and security products, electrical and electronic wire and cable, leased 96,000 square feet at Northlake 95 on Washington Highway in Ashland, VA.

Virginia Eye Institute occupies 6,000 square feet of space in a newly constructed office building near Memorial Regional Medical Center. Additionally, Virginia Urology occupies a new adjacent medical office building.



Hanover Foils, a flexible packaging converting company, added a new \$4 million line to its 80,000 square foot facility at 301 Hill Carter Parkway in Ashland, Virginia. Hanover Foils was formed in 2009 after the closure of Reynolds Metals Company plant in Richmond, which left dozens of companies without a supplier for the foil they needed for packaging, pharmaceutical and food products. After locating to Ashland for its proximity to a workforce of engineers and mechanically skilled workers, the company has continued to witness strong growth.

The new line was built to coat heavy gauge foil products with chemical resistant coatings and sealants, allowing the company to produce foils for several different industries including cable wraps, coated food service pans, fin stock for HVAC systems, industrial insulation and pharmaceutical foils. Hanover Foils included a Regenerative Thermal Oxidizer (RTO) in the build of its new line, which destroys air pollutants emitted from process exhaust streams at temperatures ranging from 815 to 980 degrees Celsius.

#### BON SECOURS MEMORIAL REGIONAL MEDICAL CENTER

In the summer of 2020, **Bon Secours Memorial Regional Medical Center (MRMC)** received approval from the Virginia State Health Commissioner to its application for a Certificate of Public Need to increase its bed capacity. MRMC purchased the adjacent Sheltering Arms facility and will complete a \$50 million renovation to add 11 intensive care units and 33 surgical beds.



#### **OWENS & MINOR**

Owens & Minor, a Fortune 500 medical supply company headquartered in Mechanicsville, expanded its production to meet demands created by the pandemic. Future plans include an expansion of its campus with the addition of a distribution center and a surgical kit assembly facility.



Additionally, Blazer works with the Hanover Center for

Trades & Technology to employ HVAC apprentices, and is an enthusiastic sponsor of Hanover youth sports.



#### PITCH COMPETITION

Each year, the Dominion Energy Innovation Center and Randolph-Macon College (R-MC) welcome emerging technology and sustainability-focused startups across Virginia to apply for its Pitch Competition. This year's competition was held on February 25, 2021 via an online platform. From a large pool of competition applicants, eight teams made it through to the finals, and only three were selected as grand prize winners by a group of distinguished judges.



With unanimous approval by the Board of Supervisors and the Hanover County Economic Development Authority, the Department of Economic Development launched the Small Business Resiliency Grant program to support small businesses adversely affected by interruptions and mandated business closures due to COVID-19. The grant also received support from the Hanover County Chamber of Commerce and business owners. The Hanover County Small Business Resiliency Grant, which leveraged \$300,000 of federal funding under the CARES Act, offered up to \$7,500 in recovery funding to eligible businesses with 50 or fewer employees.

Applications were received during two separate rounds between July 27 and September 14, 2020. Businesses approved for funding met eligibility requirements, submitted proof of payment for eligible expenses, and were in compliance with Hanover County's registration and tax filing requirements. Of the 73 applications received, 58 were funded for a total amount of \$270,384. The 58 approved applicants employed a total of 588 people as of June 1, 2020. Additionally, 53% were Small, Women-owned and Minority-owned (SWaM) businesses, and more than 70% of applicants had fewer than 10 employees.

"We are grateful to the Hanover County Board of Supervisors for recognizing the importance of supporting our local small business community through our CARES Act Resiliency Grant Program," said Linwood Thomas, Director of Economic Development. "These businesses are the backbone of our community, and it is nice to be able to help them recover some of the investment they have been required to make during the pandemic to continue their operations."

Hanover businesses received grants totaling more than \$270,000.





Vinh Vo, owner of Pampered Nails and Spa, used the grant to purchase plexiglass dividers, hand sanitizer and other Personal Protective Equipment (PPE) to enable his business to safely continue operations after the State mandated closure of certain businesses types was lifted.

# **WORKFORCE ASSISTANCE #WORKFORCEWEDNESDAY**



To assist Hanover businesses with advertising open positions to prospective employees, our department began featuring a Hanover-based business every Wednesday on our social media platforms with links to our Hiring in Hanover, VA app using the hashtags #HiringinHanoverVA and #Workforce-Wednesday. Since March 2021, 13 companies have been featured with more than 2,900 views on Facebook and 3,300 views on LinkedIn.





#### **Business Walks**

Hanover County Economic Development continued its business outreach utilizing staff and volunteers through its Business First program. Two business walks were conducted in FY-21 of Route 1 and Old Mechanicsville with 53 businesses visited.



#### Virtual Career Fair

In collaboration with Virginia Career Works Center-Capital Region and other regional partners, Hanover County Economic Development hosted a virtual hiring event on October 22, 2020. Participating businesses offered immediate job openings.



#### **Capital Region SBDC**

In late November 2020, the Small Business Development Center relaunched in Greater Richmond through support of the region's localities and economic development offices. The SBDC offers technical assistance and resources to the business community.



Hanover County Economic Development (HCED) continued to intensify promotion of sites and buildings utilizing the department's website and social media platforms. This additional emphasis on digital content was critical during this past year as travel disruptions made it nearly impossible for prospects and consultants to have boots on ground in the community.

Prioritizing virtual content was timely as prospect interest in the community accelerated as the year progressed. With global supply chains continuing to shift, and a desire to have more logistics and production facilities in the United States, the Greater Richmond Region has garnered significant attention as an outstanding location in which to establish a business. In FY 2021, Hanover County responded to 101 prospect leads (defined as companies/ consultants with a specified project) that came to us directly and from our local partners at VEDP and GRP, which is a 29% increase over FY 2020 and the highest level since FY 2018.

Despite significant travel disruptions this previous year, HCED was able to take part in 51 prospect visits to Hanover. These prospects included businesses actively seeking a location for a project, site selection consultants, as well as trade/embassy officials. Of these visits, nearly 76% were held virtually to accommodate health and travel restrictions.



#### **AREA DEVELOPMENT SUMMER CONSULTANTS FORUM**

Area Development Magazine, considered the leading executive magazine covering Consultants Forum. Held in-person in June 2021 at the Jefferson Hotel, the multi-day event provided an opportunity to network with leading site selection consultants and industry experts from across the nation. Brandon Turner, representing Hanover County, attended as part of a strong delegation from the Richmond Region.



#### **SELECT USA** VIRTUAL TRADE MISSION

HCED took part in a virtual trade mission with Select USA, the business development arm of the United States Government. In addition to presenting the Richmond Region to several dozen global business and site selection leaders, the region also followed-up directly with several companies looking to establish a presence in the U.S.



#### **DUNDEE AND ANGUS CHAMBER OF COMMERCE**

HCED and the Greater Richmond Partnership were Richmond Region, to the Dundee and Angus Chamber of Commerce. Hosted by the Scottish North American Business Council, presentations were made to nearly a dozen Scottish-based businesses interested in having a presence in the U.S.




year with capacity restrictions. Kings Dominion rolled out a scaled-back version of its popular WinterFest incorporating holiday treats and traditions.

According to the 2020 Economic Impact of Visitors in Virginia prepared for the Virginia Tourism Corporation, visitation declined by 26.6% with visitor spending dropping by 39.7% as the pandemic severely affected travel as a result of closures and restrictions. Even so, more than 84.4 million visitors still traveled to and within Virginia spending \$17.5 billion. Prior to the pandemic, visitor spending in Virginia was growing on average 4.8% per year from 2016 to 2019.

In Hanover County, local tax receipts from lodging over the past decade were averaging gains at 8% each fiscal year. Following trending data reflecting the adverse effects of the pandemic on the travel industry, Hanover experienced a 23.7% decrease in hotel tax revenue for fiscal year 2021. In light of the significant financial impact at the onset of the pandemic, the Hanover Board of Supervisors adopted Ordinance 20-07 in March, 2020 as an emergency ordinance to provide temporary relief from applicable penalties and interest of transient occupancy taxes and water and sewer charges. On May 27, 2020, the Board adopted Ordinance 20-09 to continue this relief through August 20, 2020.

Situated on an old forest mix of loam, sand and clay soils of Kersey Creek, smack in the middle of the world famous Hanover tomato growing area, farmers David Hunaker and Barbara Hollingsworth grow more than 200 varieties of tomatoes, a wide diversity of herbs, chiles and specialty items using organic, biodynamic methods.



The Five-O's Tiki Foundation (FOTF) was formed in 2018 with the mission of supporting law enforcement officers and their families in times of need as well as other community initiatives. The Foundation's Concert Series is just one of many event platforms used to raise funds and awareness to achieve its goals. After hosting a successful soft opening in the summer and fall of 2019, the pandemic shelved the performance lineup during the 2020 season. With restrictions loosened as vaccinations rolled out, the Hart Nissan Concert Series benefitting the Five O's Tiki Foundation hosted a very successful 2021 season at Richmond Harley Davidson located in Ashland, VA with ten events including national and local talent.

#### **James River Cellars Winery**

James River Cellars Winery enhanced its outdoor space with a permanent 48 foot by 80 foot pavilion on its back lawn. This new space is ideal for the winery's many events, private functions and weddings. The pavilion provides a spacious covering over a stone patio with tapered retaining wall on three sides. The venue is adorned with lighting and ceiling fans and includes various sized tables and white chairs for up to 150 guests. In addition to the main Pavilion structure which features a small elevated seating/stage area, this rental option includes a secondary tented structure that can be used as a band stage, and offers a beautifully landscaped spacious lawn adjacent to the pavilion.

#### **VTC RMLP Grants**

The Five O's Tiki Foundation Concert Series, Hanover Tavern Foundation and Center of the Universe Brewing Company were all awarded grants from the Virginia Tourism Corporation's (VTC) Recovery Marketing Leverage Program (RMLP). This program was designed to help local and regional tourism entities attract more visitors by leveraging limited local marketing dollars through a local match of the state grants funds. The COVID-19 pandemic has had a devastating impact on the tourism and hospitality industries in Virginia. As the Commonwealth slowly reopened for business, VTC offered these grant funds as a first step to re-entry into the marketplace to spur economic activity and future travel across Virginia.

## **Paycheck Protection Program**

The Paycheck Protection Program (PPP), a \$600+ billion business loan program established by the United States federal government in 2020 through the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), was structured to help certain businesses and entities continue paying their workforce.

The Program, which ended on May 31, 2021, allowed entities to apply for low-interest private loans backed by the U.S. Small Business Administration to cover payroll and other specific costs. Additionally, some borrowers were eligible for PPP loan forgiveness.

The greatest number of Hanover businesses that received PPP loans are in the restaurant and construction industries.





## **UNEMPLOYMENT & LABOR FORCE**





## **AVERAGE ANNUAL WAGES**





## **NET NEW JOBS IN ALL INDUSTRIES**





## **NET CHANGE IN NUMBER OF JOBS PER TARGET INDUSTRY**





# PERCENTAGE OF TOTAL TAXABLE ASSESSED VALUE BY PROPERTY TYPE





## TOTAL TAXABLE ASSESSED VALUE OF COMMERCIAL PROPERTY




