Dear Community Stakeholders,

This past fiscal year has brought tremendous change to the Department of Hanover County Economic Development. The change in team members has meant shifts in workload responsibility, at times leaving the office with only three staff members present. Team members have had to pivot and learn new tasks, often with little time to prepare, in order to address continually evolving economic conditions, strong prospect activity, and increased growth and need from the local business community. Despite the challenges faced, the Department has excelled to meet and exceed all goals for the year, diligently working to continue marketing the County to the outside business world while providing stellar response and service to the hundreds of existing County businesses we directly worked with in FY 2023.

Hanover County continues to experience strong growth as the economy rebounds from issues related to the COVID-19 pandemic, global supply chain disruptions, and geopolitical concerns. For the first time, we are reporting the Gross Domestic Product (GDP) of the County. While there is nearly a year lag time in reporting by the U.S. Bureau of Economic Analysis, the County's GDP growth from calendar year 2020 to 2021 was 10.6%, growing faster than the national average of 10.1%. The CY 2022 calculations will be presented late in 2023, and we anticipate another strong year of GDP growth for Hanover, reflecting continued investment by businesses in the community. The County's Labor Force hit a record high at the end of FY 2023, with 63,240 individuals in the workforce and eclipsing the previous record high of 60,172 ending CY 2022. Sectors such as logistics/warehousing, professional/technical, and information/technology lead the community in job creation growth, with each category increasing over 10% for the year. Along with strong labor force growth, the Average Annual Wage in the County grew over 10% from CY 2021 to CY 2022 to a record \$54,047.

Additional construction and delivery of industrial product, including East Coast Commerce Center, Cardinal Commerce Center, and Northlake II, has helped address a serious shortage of industrial space on the market while also welcoming companies such as Ferguson and SanMar into the community. While vacancy rates for both flex and industrial have ticked up to 4.5% and 3.1% respectively, these are still very low rates and reflect a continued tight industrial market in Hanover. Retail and office construction have been small-scale and somewhat limited in the County in the past few years, and combined with population growth, we are witnessing both sectors at record low vacancy rates (4.3% for office and 2.2% for retail). New retail development is proposed for the County which will help address the low vacancy rate and offer opportunity for additional businesses to establish. Richmond Region Tourism's initiatives to enhance and grow tourism in the region are paying huge dividends, with record lodging tax revenue of almost \$1.46 million collected by hotels in Hanover County in FY 2023, an 8.1% increase of last year's record \$1.35 million collected. It has been an outstanding year for business in Hanover County!

As we now move into FY 2024, the Department of Economic Development will build upon the foundations of the County's Comprehensive Plan Update and the Targeted Industry Cluster Analysis to commence with updating the Economic Development Strategic Plan. This plan will be developed with significant input from stakeholders throughout the County and region, focusing on strategies to target high quality investment and intentional development in identified strategic economic development areas. In addition, the Department will continue reaching and working with existing businesses to identify ways to mitigate barriers where possible and identify opportunities for further growth. The Department will also continue leveraging partnerships with the Hanover Chamber of Commerce, Town of Ashland, Virginia Economic Development Partnership, Greater Richmond Partnership, Dominion Energy Innovation Center, Richmond Region Tourism, and ChamberRVA, among others, to further enhance the business climate of Hanover County.

In closing, I give my most sincere thanks to local Hanover businesses, Board of Supervisors, County and community leaders, and the Economic Development Authority for your continued support through a year which has brought so much change to the Economic Development Department and the overall County economy. Economic Development is a team sport, and our community's continued success would not be possible without each and every one of you!

Gross Domestic Product (GDP) 2021: All Industry Total - Hanover County, VA




PRODUCT DEVELOPMENT

Fiscal Year 2023 showcased another year of robust speculative industrial development within the Suburban Service Area, presenting more opportunities for companies to establish operations here in Hanover County.









This new development consists of two 200,250 square feet Class A industrial warehouse facilities subdividable down to 50,000 square feet. Zoned M-2-light industrial, these buildings delivered in Q3 2023.

<1 mile from I-95 via U.S. Rte. 1-Washington Hwy

Lakeridge Logistics Center

This new speculative industrial project, located along the southern Lakeridge Parkway corridor on approximately 27 acres of property, is a two-building development started in spring 2023 with completion anticipated in Q1 2024.

<1 mile from I-95 via Sliding Hill Road

River Point Commerce Center

This new speculative flex/industrial park will break ground in late 2023. Delivery of the first two buildings in Phase I (Buildings #1 and #3) of this three-building industrial development should come online approximately Q4 2024, with Building #2 to follow in Phase II.

INTERSTATE 95/U.S. ROUTE 1 CORRIDOR

Interstate 95 and its predecessor, U.S. Route 1, connect the eastern seaboard from Maine to Florida and bisect Hanover County. As one of the most powerful economic corridors in the nation, it has been the historic epicenter of trade and development in the County. New industrial parks in this corridor, such as Cardinal Commerce Center (shown under construction top center), Nashington Highway Industrial Development, and Northlake II, add to the existing parks providing millions of square feet of industrial product that have created thousands of jobs in the community. New retail and hospitality businesses also continue to spring up in the corridor including Hobby Lobby, WoodSpring Suites, and Starbucks among many others.



flex, warehouse & distribution space is proposed, under construction at the end of FY 2023.

As part of the Greater Richmond Region, Hanover County shares in the national and international glow as a destination for businesses ranging from logistics to pharmaceuticals to advanced manufacturing. Years of strong business growth had suppressed industrial and flex vacancies to historic lows. The addition of hundreds of thousands of square feet of new industrial and flex space has given the market some breathing room this year, with vacancy rates increasing to 4.5% for flex space and 3.1% for industrial. While still low, slight increases in vacancy rates indicate more opportunities for new and existing businesses to find space in the County.

Continued collaboration and partnerships with private landowners and industrial developers have helped bring this much needed inventory to the market. In FY 2023, approximately 1,593,700 s.f. of new flex and industrial space came on the market in the County, with East Coast Commerce Center's 1.1 million s.f. building representing the vast majority of that space-the largest speculative building ever constructed in the County. Over the next five years, Hanover County has approximately 3.94 million s.f. of industrial and flex space planned,

proposed, and/or under construction. Despite some minor slowdowns in the market from COVID-19 record activity, leasing and prospect activity remains high in the County, and it is anticipated much of this space will be leased shortly after it comes online.

Unlike many localities in the United States, Hanover County continues to witness near historic low office vacancy rates of approximately 4.3%. This contrasts with a national office vacancy rate of approximately 12.9% (CoStar, Q2 2023). While population and business growth in Hanover County have helped keep office vacancies low, the County also has not traditionally been a large office market, and very limited office has been constructed in the past five vears. Much of the new construction has been small scale office "condo" buildings. Also of note is the retail vacancy rate which dipped further in FY 2023 to 2.2%, a near historic low. Limited retail construction has not kept up with demand for businesses to cater to population and tourism growth in the County, reflecting the low rate. New retail is being proposed for the County in the near future, and the low vacancy rates will likely entice developers to consider additional retail space on properties identified for retail/commercial development.



Lewistown 95 Logistics Center. Located in the heart of the Winding Brook area, one of Hanover County's most sought after mixed-use communities, tenants of this facility nearing completion will enjoy easy access to nearby retail, restaurant, residential and lodging amenities including a new WoodSpring Suites and Hobby Lobby opened in late Summer 2023. This new 552,000-square-foot warehouse, situated on 43 acres at 11517 Lakeridge Parkway, will be owner occupied by Genpak, a food packing firm owned by The Jim Pattison Group, a Canadian conglomerate. Genpak will occupy a bulk of the warehouse with the remaining 150,000 square feet available for lease.

BUSINESS INVESTMENT

While capital investment remains strong in Hanover, job creation has reached a new high, with more projects in the pipeline.

SanMar Corporation, a leading supplier of wholesale accessories and apparel, will invest at least \$50 million to establish a distribution operation in the East Coast Commerce Center in Hanover County. The 1.1 million-square-foot speculative distribution building was developed by Equity Industrial Partners Corporation and Raith Capital Partners and will be SanMar's flagship center for the company's east coast distributions. SanMar, headquartered in Issaquah, WA, celebrated its 50th anniversary in 2021. Virginia successfully competed with North Carolina for the project which will create up to 1,000 new jobs when the facility reaches full capacity.

Unilock, North America's premier manufacturer of concrete interlocking paving stones and segmental wall products, will invest \$55.6 million to establish a manufacturing campus in Hanover County. The company will locate up to four new production facilities at 17000-17500 Washington Highway in Doswell to meet increased customer demand within the Mid-Atlantic and Southeast markets. Virginia successfully competed with Georgia and Maryland for the project, which will create 50 new jobs. Headquartered in Toronto, Canada, Unilock is a family-owned and -operated business that

originally introduced the paving stone to North America in 1972. The multinational company, backed by family values and a commitment to quality, distributes products across Canada and to 30 U.S. states from 13 manufacturing sites in Ontario, Wisconsin, Illinois, Kansas, Michigan, Ohio, New York, and Massachusetts. Architects, landscape architects, and engineers have relied on Unilock products for decades to build world-class commercial spaces across North America.





BUSINESS INVESTMENT: PROGRESS UPDATES





Cascades Inc., a leader in the recovery and manufacturing of green packaging and hygiene products, produced its first roll of 100% recycled containerboard in May 2023 at its Bear Island plant located in Ashland, VA. With annual production capacity of 465,000 short tons of lightweight, high-quality, 100% recycled containerboard, the state-of-theart mill is equipped to perform within the top quartile of its industry, and will strengthen the operational flexibility, geographic footprint, and competitiveness of Cascades' Containerboard platform. The project, first announced in July 2018, created 700 jobs in the region during the construction phase, and 180 permanent jobs with the onset of commercial production.

ABB, a multinational technology company, opened a new manufacturing, distribution and repair center in the Atlee Station Logistics Center in June 2023 to support its motion traction business.

ABB's Motion Traction division offers a comprehensive range of high-performance products for use in passenger railway cars and e-mobility commercial vehicles. The facility is equipped with state-of-the-art manufacturing equipment to produce converters and batteries for the railway and transportation industries as well as electric off-road construction machinery for mining and electrical buses.

The \$6 million investment includes more than 65,000 square feet of operational space and will employ nearly 100 skilled production workers when at scale.





Wegmans Food Markets, Inc., a grocery retailer with stores throughout the Northeast and mid-Atlantic, announced in December 2019 of its planned 1.1 million-square-foot regional logistics and office operation in Hanover County, representing \$175 million in capital investment and creation of 700 new jobs. Work has progressed rapidly on the facility, with the anticipation of all construction to be completed and the facility to be operational by the end of 2023. The new campus allows the company to expand its distribution network on the East Coast and accommodate its growing retail footprint. Wegmans, in business for more than a century, currently has more than 100 stores across eight states and D.C. with more locations planned. Commercial activity remains high in Hanover County in response to increasing wages and population growth, bringing a number of new dining and retail options to the community in FY 2023.

Cross Creek Nursery and Landscaping opened its newest nursery and garden center on a 15-acre site at 15503 Ashland Road in Hanover County, near the intersection with Pouncey Tract Road. A ribbon cutting ceremony organized by the Hanover Chamber of Commerce was held on May 17, 2023.

Cross Creek launched in 1974 as a plant store called Tropical Treehouse in Carytown under Gene and Diane McAuliffe. They continue to own the company, with son Mark and his brothers Jason and Andrew overseeing day-to-day operations.

It is the company's second nursery, adding to its existing location in Chesterfield, and employs approximately 35 people. The Hanover site brings the company closer to existing customers and positions it to tap into new customers in this region.



BUSINESS INVESTMENT: FOOD & DINING

Rio Brazil Steakhouse opened in its Wigwam Crossing location at 10412 Washington Highway in November 2022. The restaurant occupies approximately 25% of the 15,000-square-feet multi-tenant commercial building.

The Lazy Cow Ice Cream Parlor, based out of West Point, VA, opened a Hanover location in 2023 at 7038 Mechanicsville Turnpike. Owner Amanda Franklin fulfilled her long-standing dream of opening her own stores.

Great American Ranch, opened a second area location at 7514 Lee-Davis Road in Mechanicsville in May 2023. The 15,000-square-foot country-style restaurant and saloon also hosts live music and a mechanical bull.

Lickinghole Creamery & Gifts, opened in July 2022 at 10368 Leadbetter Road. Owned by Ed and Stacy Whipple, the shop serves locally sourced ice cream with seating available in their quaint gift shop.

Northlake Business Park

Northlake Business Park features several million square feet of existing office, retail and industrial space on approximately 400 acres. Given its convenient location between U.S. Route 1 and Interstate 95, Northlake's resident companies include Amazon, Blue Bell Creameries, Architectural Products of Virginia, Lutron, Richmond Harley Davidson, Creative, Owens & Minor, General RV, and many more.

Northlake II (pictured under construction June 2022)

Northlake II is a four-building, two-phase from the ground up flex project totaling approximately 557,000 square feet in Ashland, VA. With quick access to, and visibility from, Interstate 95, Phase I of Northlake II will house Ferguson, Chadwell Supply, Metropolitan Warehouse & Delivery, and Jones Signs. As of the end of Q2 2023, clearing had just commenced on Building 4 which will add about 202,000 square feet to the complex around summer 2024.

Bon Secours Names New President On July 31, 2023, John Emery was named as president of Bon Secours Memorial Regional Medical Center and Rappahannock General Hospital. In his new role, Emery will be responsible for the overall operational success of these two hospitals, while focusing on compassionate, quality patient care. He succeeds Leigh Sewell who stepped down as president in May 2023 after 17 years with Bon Secours Richmond to pursue other career interests.



Bon Secours Memorial Regional Medical Center (MRMC), held a ribbon-cutting ceremony in November 2022 for its nearly completed West Pavilion. The 48,000-squarefoot wing is a building on the campus that Bon Secours purchased from Sheltering Arms in 2021. The new wing features 43 in-patient beds and is home to neuroscience and orthopedic units in addition to physical therapy and rehabilitation services. The West Pavilion renovation comes as part of a larger \$50 million renovation project at the hospital, which received approval of its Certificate of Public Need application in 2020. The addition of the West Pavilion brings Memorial Regional to a total of 270 beds and 436,500 square feet. The medical campus, located at 8260 Atlee Road in Mechanicsville, currently has about 1,600 employees and plans to add several dozen more as part of the expansion project.

The company manages 30 field offices in 13 states, employs more than 165 people, and has completed over 21,000 jobs since its inception in 2009.

Jones Sign, an industry leader in signage solutions since 1910, announced the expansion of its Ashland, Virginia facility. Located only three miles north of the company's previous facility, the new building located in Northlake II, has 33,000 s.f. of production floor, more than doubling its previous footprint. The expansion has created the need to hire more employees.



Lutron Expands Operations in Hanover, VA

Lutron Electronics, the Pennsylvania-based trusted global leader in lighting control, automated shading solutions, and intelligent fixtures, announced in the fall of 2022 of its investment of \$28.3 million to build a manufacturing facility adjacent to its existing building in Hanover County. The 145,000-square-foot facility, which broke ground on November 1, 2022, will increase the company's shading solutions manufacturing capacity and create approximately 200 new jobs. The Virginia Economic Development Partnership worked with Hanover County to secure the project for Virginia. Governor Youngkin approved a \$250,000 grant from the Commonwealth's Opportunity Fund to assist Hanover County with the project. Funding and services to support Lutron Electronics' employee training activities will be provided through the Virginia Jobs Investment Program.



Lutron already has a sizeable shade factory in Ashland, and the new facility will be adjacent to the existing one, enabling the company to build a campus-like environment. This new state-of-the-art facility, coupled with our steadfast commitment to quality, unrivaled investments in innovation, and world-class training and technical support makes Lutron a strong bet for the future. When the new facility is online, it will mean Lutron's shade manufacturing capacity will be 30% to 50% higher than it is today, which will result in reduced lead times for CE (custom electronics) pros ordering products. ??

Linebird, based in Ashland, VA, was awarded a Virginia Innovation Partnership Corporation's Commonwealth Commercialization Fund (CCF) grant of \$75,000. The company has developed the Osprey nonconductive payload system that pairs with commercial-grade drones to give linemen safer and more cost-effective access to live-power utility infrastructure.

SPARK VA Awarded EPIC Grant

In December 2022, DEIC was named as a semifinalist in the U.S. Department of Energy's EPIC Prize Challenge. Along with the recognition of being one of the top 24 energy incubators in the United States, DEIC was awarded a \$50,000 grant to develop new programming in support of nuclear and hydrogen technology startups. SPARK Virginia, the DEIC's EPIC proposal, specifically identified nuclear and hydrogen as key technology areas that Virginia has been a global leader in at all levels, including at the Commonwealth's public research universities, federal government labs, and private energy companies. Hanover County is uniquely positioned to help support advanced energy startups because of its central proximity to the State's existing nuclear fleet and its position along I-95, a key transportation corridor that will eventually be serviced by a series of hydrogen fueling stations.

2023 Accelerate Cohorts In May, DEIC unveiled the ten climate techfocused startups chosen for its 2023 DEIC Accelerate cohort, marking the first time the program has expanded to include more than eight companies. The program, created to connect energy and sustainability startups with their next major customer and investor, will run for 18-weeks from June through October. The selected startups will receive mentorship and an opportunity to develop pilot programs with DEIC's partner network, including Dominion Energy. The aim is to foster these startups in a way that continues to establish Virginia as a frontrunner in providing clean, reliable, and affordable energy. Among the selected businesses, there's a diverse range of innovative approaches to renewable energy and sustainability. Since its inception in 2020, the Accelerate Cohort has graduated 22 start-up companies.

Ag-X Workshop Series

DEIC partnered with SCORE-Richmond to once again host the Ag-X Workshop Series, the first business planning series in the region specifically targeted at helping Central Virginia agri-enterprises scale their food, forestry, fiber or agriculture products and services business. Seven entrepreneurs attended the 10-hour series and earned course certificates. HCED offered scholarships and awarded one to a Hanover-based business.

Pixel Factory Data Center was named the recipient of the 2022 Marc S. Weiss Award at the Hanover County Business Appreciation event. The award, presented by County Administrator, John A. Budesky, was accepted by Scott Brown, Niki Desantis and Logan Whitton.

Scott Brown, owner, started the business for his growing commercial photography business and the industry's need for digital storage of images for large corporate clients. Pixel Factory Data Center now boasts the largest concentration of fiber in the area, and the company continues to grow by leaps and bounds, having gone from a solely U.S. client base to an international footprint.

The vision and purpose of the Marc S. Weiss Award is to recognize a Hanover-based business or entity which has demonstrated a lasting commitment to innovation, meaningful growth, global involvement, and leadership and service within the Hanover community.

During FY23, our department conducted 153 business visits and assisted 162 Hanover businesses.

Rapid Response to Plant Closure

In March 2023, Tyson Foods Inc. provided written notification to the State and Hanover County pursuant to the Worker Adjustment and Retraining Notification Act of 1988 (WARN Act), which requires employers to provide at least sixty (60) days notice to team members, their representatives, and certain governmental units and government officials of a mass layoff or, in this circumstance, a plant closure. The notice stated that as part of the Company's business strategy to operate more efficiently, Tyson Foods determined that it must eliminate all 682 jobs by mid-May 2023 at its Glen Allen processing plant located at 13264 Mountain Road while simultaneously announcing the closure of its plant in Van Buren, Arkansas. In early August, Tyson announced the closure of four additional plants in the central U.S.

Hanover County's Department of Economic Development worked closely with Virginia Employment Commission's Central VA Rapid Response Team and Virginia Career Works immediately following the plant closure announcement. Virginia Career Works coordinated a series of on- and off-site recruiting events, and also provided representatives on-site to share information and resources. A dedicated webpage was created on our department's website to assist with relaying resources available to the displaced workers. The department's "Hiring In Hanover, VA" app was offered as a resource, and was advertised in several languages. Additionally, the team mobilized quickly to alert other local employers looking to hire of upcoming job fair opportunities to meet with the displaced workers.

A Hanover County-based non-profit business, Kitchen 33 and Bakery, served the affected Tyson Foods workers in a meaningful way. Located just half a mile from the soon to be shuttered Tyson plant on Route 33, the eatery donated private event space to host three job fairs in early May.

Business Event Collaborations

Hanover County encourages small businesses to innovate, prosper, and grow here. Through an extensive network of resources and partnerships with other public and private organizations providing small business and entrepreneurial assistance, we frequently co-sponsor workshops, seminars and events on a wide variety of business topics. In May 2023, our department co-sponsored a GENEDGE event held at DEIC which targeted manufacturing companies. In partnership with the Virginia Department of Small Business and Supplier Diversity (SBSD), an event held at the Atlee Library earlier in May focused on small business record keeping and taxes.



Business Walks

Hanover County Economic Development continued its business outreach utilizing staff and volunteers through its Business First program. Five business walks were conducted in FY23 of the Hanover Industrial Airpark (2), Fox Ridge, Lakeridge, and Kings Charter areas resulting in 88 businesses visited.

HCED offered scholarships to Hanoverbased businesses interested in attending the agricultural workshop series. One Hanover-based agricultural business applied and received tuition reimbursement upon successful completion of the in-depth series. For more Aq-X details, see page 17.

SBDC VA Capital Region

The Capital Region Small Business Development Center helps individuals start or grow their business with expert advice and free resources. In addition to funding received from the U.S. SBA, America's SBDC and VA SBDC, the Center receives support from Hanover County and regional co-partners.

MARKETING & PROSPECT DEVELOPMENT

Economic Development is most effective when working closely with strong partners and leveraging those partnerships and assets for success. Hanover County Economic Development (HCED) continues to build on deep partnerships with the Greater Richmond Partnership (GRP) and Virginia Economic Development Partnership (VEDP) to connect the County with project leads and market the community to both national and international markets.

Through in-market visits, external outreach, and virtual meetings, HCED witnessed another robust year of lead and prospect generation and visitation. In FY 2023, HCED responded to 75 prospect inquiries, which are considered projects that are actively scouting for sites/buildings to establish operations. Both of these numbers have decreased since the record highs of a few years ago but are still historically very strong for Hanover County and show continued interest from the external business community in considering the County for potential projects. These prospect leads represent a diversity of industrial sectors including pharmaceutical, data center, battery manufacturing, electric vehicle, and other advanced industrial uses.

HCED also hosted 61 prospect visits to the community during FY 2023. Prospect visitation has changed dramatically since the onset of COVID-19, where now strong emphasis is placed on virtual visits instead of in-person. Following this new trend, the percentage of virtual visits in FY 2023, which was about 40% of the 61 total visits, increased from FY 2022 when 18% of visits were held virtually. Pent-up desire to travel rebounded in FY 2022 after COVID restrictions were lifted, but higher costs and the time associated with business travel has resulted in the noticeable uptick in virtual visits during FY 2023.



Atlanta/Greenville Marketing Mission


Locality Familiarization Tours

ORIGIN

When promoting a county and the region's sites and buildings to external businesses, it is imperative economic development professionals and site selection consultants truly understand the community's assets. This is best handled through familiarization tours, where attendees are provided tours not only of the community's real estate assets but also neighborhoods, schools, parks, restaurants, and other resources and amenities. It is important to showcase the entire picture to economic development professionals and consultants so they can effectively relay a community to business prospects. Understanding of a community's true character and assets is important because businesses do not choose locations based on real estate alone; they are looking for a community in which their values and needs are fully met. HCED took part in several familiarization tours in the County in FY 2023, providing comprehensive tours for over 20 site selection consultants, state and regional economic development professionals, and local leaders.

Amtrak serves Ashland's historic train station situated in the center of town and adjacent to Randolph Macon College

Virtual Prospect Meetings

Prior to COVID-19, most all prospect meetings were held in-person either at a client's facility or in the community for which the real estate was being reviewed. With the shift to more technology and remote meetings during the pandemic, the number of in-person visits dropped dramatically. While rebounding slightly, a significant amount of prospect activity and visitation continues to be held virtually. Through platforms such as Zoom and Microsoft Teams, these meetings can be held more quickly and efficiently, relying more heavily on videos, drone imagery, and GIS tools than in the past. Of the 61 total visits to Hanover County in FY 2023, nearly 40% were held virtually, many of which were with site consultants and/or prospects not located within the United States. Virtual meeting options open windows for interaction with prospects who otherwise may not be able to easily visit Hanover County, further broadening the County's outreach to the external business market.

Hanover County **Property of the Week**

Continuing a successful initiative Hanover County Economic Development commenced in 2021, the office continued promotion of key sites and buildings in FY 2023. These commercial and industrial sites and buildings are all identified as development and/or move-in ready, and are in the process of being actively marketed by landowners and/or brokers. Shared via social media and viewed by a growing number of brokers and site selection consultants, more than 85 properties have been featured since 2021 with nearly 40,000 views.







Hanover Shopping Season

Throughout November and December of 2022, our department encouraged consumers through its Hanover Shopping Season campaign to "Shop Local" and to consider dedicating part of their holiday spending in support of local and small businesses. The campaign touted the County's retail establishments, restaurants, personal service providers, and other businesses that count on our patronage.

The Hanover Shop Local Season was promoted through social media posts and print ads in The Mechanicsville-Ashland Local, and encompassed Black Friday Shopping Deals, Shop Small Saturday, and Cyber Monday. A special blog post with social media shares encouraged



Apps Promotion

As businesses pivoted to adjust to new working conditions created by the pandemic, our department's outreach efforts quickly uncovered the need for a local job board to assist our local businesses and job seekers. Hanover County Economic Development created the Hiring in Hanover, VA App in July 2020 using the Glide platform to satisfy the numerous requests from Hanover-based businesses. Anyone can access the App from any device – mobile, tablet, or desktop, and the App can easily be shared with a simple web link or QR Code. Ashland Dairy Farm Announces New Creamery Venture

Thomas E. Stanley & Sons Dairy, Hanover County's last remaining dairy, is taking the opportunity to tell their agriculture story and connect with consumers directly by appealing to their palates by opening a creamery. The Stanley family has opened White Oak Dairy to visitors and offers sales of ice cream from its mobile trailer and wholesale customers to help position its generational farm for a bright future.

The Stanleys' value-added venture, named Farmview Creamery, started with purchased ice cream mix but has transitioned to on-site production. Prior to the announcement, they were awarded a Southeast Dairy Business Innovation Initiative grant to fund a feasibility study, with application assistance from the Virginia Foundation for Agriculture, Innovation and Rural Sustainability (FAIRS). VA FAIRS helps farmers start and expand into value-added, high-value agriculture enterprises.

The Thomas E. Stanley & Sons White Oak Dairy, a Grade A 265-acre farm, is now owned by its second and third generations, William Stanley and one of his two sons, Joel Stanley, who runs the day-to-day operations alongside his wife, Missy Stanley.

The U.S. has lost more than half of its licensed dairy operations since 2003, down to 32,000 dairy operations, according to a 2020 U.S. Department of Agriculture report.


VISITOR EXPENDITURES (CY22)

In Hanover County, local tax receipts for the 2023 fiscal year generated \$1,464,217 in lodging taxes, which represents an 8.1% increase from last fiscal year. The County, along with the Richmond Region as a whole, set another year-over-year record for annual occupancy tax revenue in 2023. Sports tourism continues to make a significant economic impact on the region representing more than 65% of Richmond Region Tourism's bookings. Beginning July 2023, the area's Tourism Improvement District (TID) initiative began collecting an additional 2% fee on nightly hotel rates to help Richmond Region Tourism attract and entice events, sports, meetings, and conferences to the Greater Richmond Region while advertising the area's many offerings.



Esther Manor Farm, founded at the height of a global pandemic, is a black-owned, female-owned farm located in the heart of Beaverdam, Virginia. Longing for natural environs that reminded owner Patience Fielding of her youthful years at her grandmother's small holder farm in the rural setting of Bali, Cameroon, West Africa, she found the idyllic setting to establish her farm offering ethnic vegetables and produce, a community around farming, and a space for cross-cultural engagements and networking. Garden offerings include green vegetables such as bitter leaf, Njama Njama, and waterleaf.

In October 2022, a farm to-table dinner provided a highly captivating food and cultural event complete with festive music and delicious food paying homage to Cameroon's beautiful customs. Farm products were displayed with descriptions and preparation methods, giving guests a foretaste of the dinner ahead. Brandon Turner with Hanover County Economic Development was one of the guests invited to speak at the event. The U.S. Ambassador to Cameroon, was also in attendance.

On January 21, 2023, the U.S. team headed to the World Cross-Country Championships was named in four memorable races at the USATF Cross-Country Championships held at Pole Green Park in Mechanicsville, VA. Amateur, collegiate and pro athletes competed for \$45,000 in prizes.

Economic Development Strategic Plan

Anticipated completion and adoption of Hanover County's Comprehensive Plan Update in the fall of 2023 will next trigger initiatives for strategic planning in a number of County departments. Included in this round of strategic planning will be the Economic Development (ED) Strategic Plan, last updated in 2015. It will come as no surprise the County's economy has changed dramatically since that plan was established. While it had been scheduled to be updated in 2020, COVID-19 put a temporary delay on the initiative. Since the Comprehensive Plan was scheduled for updating in 2023, it was determined best to put the ED plan on hold. As the Comprehensive Plan helps guide where development will take place, and the Industry Cluster Analysis (see article to the right) informs what sectors to target, the Economic Development Strategic Plan will piggyback on these plans to determine the best strategies to guide strategic, targeted, high-quality investment into areas best suited for the use.

As part of this future strategic planning, Economic Development will be provided with an updated set of performance measures to maintain and analyze to determine if the plan is meeting its goals and objectives. These measures will continue to be reported to the Board of Supervisors and to the community through the Department's Annual Report and State of the County address. Given the dynamic and competitive nature of the larger economy, and desire to encourage and retain intentional, targeted projects into key areas identified in the Comprehensive Plan, Hanover County must proactively nurture and develop its business sector to address global economic conditions as well as needs of the local community.

Hanover County Industry Cluster Analysis Study

The Hanover Department of Economic Development procured Virginia Tech's Center for Economic and Community Engagement to provide an economic and target industry cluster analysis. The study included analysis of key demographic and economic trends, existing County assets and opportunities in relation to industry, and identification of existing and emerging industry clusters. Using a mixed-methods approach, the analysis aimed to confirm existing industry clusters and examine the County's suitability for target industries based on industry needs, regional trends, and existing opportunities. The study included industry sector target focus group meetings to gain a better understanding of the County's changing economic conditions and industry dynamics.

to update its vision for the future. The Comprehensive Plan is a longrange guide for growth and development, establishing a vision of what Hanover County could look like in twenty years. The plan addresses a variety of topics, including land use, housing, economic development, and natural resources. It identifies objectives and strategies that can be implemented to realize the community's vision.








UNEMPLOYMENT & LABOR FORCE





AVERAGE ANNUAL WAGES





NET NEW JOBS IN ALL INDUSTRIES



NET CHANGE IN NUMBER OF JOBS PER TARGET INDUSTRY





PERCENTAGE OF TOTAL TAXABLE ASSESSED VALUE BY PROPERTY TYPE





TOTAL TAXABLE ASSESSED VALUE OF COMMERCIAL PROPERTY




